In obedience to the instructions issued by the Director of Fire Services, TS Hyderabad vide reference 2<sup>nd</sup> cited, and in compliance to the authorization given in accordance with vide reference 2<sup>nd</sup> cited, as per the recommendation of Inspection reported submitted vide reference 3<sup>rd</sup>, the fire safety measures to the non-multistoried building with height of 24 ft. for Educational building with ground floor + 4 floors-Azan International School, H.No.9-4-136, Seven Tombs, Tolichowki, Hyderabad District - TS are furnished here under:

## Particulars of building as follows:

- a) Institution Name & Address: Azan International School, H.No. 9-4-136,
   ToliChowki, Hyderabad
- b) Area of plot of building: 2006.7 Sq.Mtrs
- c) No. of blocks Floors: one Lower Ground + Ground + 4 floors.
- d) Floor wise details:

- 2. The Management has provided the following safety measures:
- a) Terrace Tank 15,000 litters capacity is provided and Booster pump 450 LPM.
- b) One internal stair case width 2.70 mts provided.
- c) Two external staircase width of 1.25 mts each provided.
- d) Every room with a capacity of 50 students and above shall have at least doorways.
- 3. The following fire fighting's systems are suggested:
- a) (3) Three 12 Ltrs water expelling extinguishers.
- b) (4) Four CO2 extinguisher of each 4.5 kg capacity- for each floor.
- c) (10) Ten DCP extinguishers of each 5 kg capacity.
- d) 4 buckets 9 Ltrs round bottom fire buckets for each floor (2 buckets filled with water and two filled with sand) for every 600 sq.mtrs built up area/floor should be hang to a stand.
- e) For every 600 sq.mtrs built up area/floor, the fire extinguishers should be located as to be available within 25 mtrs radius.
- 4. The following No Objection Certificate issued for a period of one year from the date of issue subject to the following conditions:
- a) All Fire safety measures as advised should be provided without fail.
- No temporary structure such as tents or thatched construction shall be allowed for education institutions.
- c) All the staff / watch and ward staff train in first aid fighting.
- 5. The management may be informed of the following rules and regulation:
  - As per clause 13.1 of part II of, the National Building code of India neither granting of the permit not the approval of the drawings and specifications made by the authority during erection of the building shall in any way relieve the owner of such building from full responsibility for carrying out of the work in accordance with the requirements of the National Building Code of India.

- ii) As per clause 9.3 of part II of the National Building Code of India "The licensed Architect/Engineer/structural engineer/Supervisor/Town planner be responsible for supervision of the construction for the completion certificates. In the event of violation of the provisions of the code be shall be liable to penalties as prescribed by the authority including cancellation of the license.
- 6. The management may advised to installation of above fire measures and keep all Fire safety measures in good working conditions at all times.
